I. <u>APPROVAL OF MINUTES</u>

The Board VOTED 4-0 (Stephen W. Beard, Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve the Open Session Minutes of the March 20, 2013 meeting.

II. <u>CHAIR'S REPORT</u>

Note: Board Chair Stephen W. Beard joined the meeting at 3:23 p.m. and resumed his office as Chair from the Chair *Pro Tem* Russell F. Carlson.

III. EXECUTIVE DIRECTOR'S REPORT

A. <u>EDUCATION-CLASSES</u>

Since the last Board meeting, we have held 2 classes in our offices (on March 28 and April 11), and 2 classes for new employees, hosted by the Laborers International 1001 (bringing to 11 the total held in 2013 to date). A total of 59 City employees and one alderman attended.

There are currently 40 employees scheduled to attend classes on April 25 and May 9.

In addition, at the invitation of Board member Fran Grossman, I will be doing a presentation to a class in urban planning at the UIC on April 24. I will also be doing a presentation for the Federal Bar Association on June 12.

B. <u>LOBBYISTS</u>

As of today's date, we have 640 registered lobbyists, and have collected \$302,375 in registration fees. The next quarterly reporting period ended on March 31, and lobbyists' quarterly reports are due by April 20 (actually April 22, as April 20 is a Saturday). On March 30, our ELF system sent reminder notifications to all registered lobbyists regarding the April 22 deadline. To date, we have received and processed 329 reports.

To date, 84 lobbyists have completed the training program.

C. <u>ON-LINE TRAINING</u>

Education Director, Edward Primer is currently working with the Department of Innovation & Technology to have the 2013 all-employee training posted next week. It will include graphics and three short films.

D. <u>STATEMENTS OF FINANCIAL INTERESTS</u>

As of 2:30 p.m. today, 2195 employees and officials have filed Statements of Financial Interests, as required by law. This puts the City at 64% compliance. By law, on April 1, a reminder notification was sent to all persons who had not yet filed, and lists of filers and not yet filers were sent to all Department Heads and Ethics Officers. We will send further reminders on May 15.

Those who fail to file by May 31, 2013 are subject to a \$250 per day fine and to their names being made public.

G. <u>Illinois Freedom of Information Act</u>

Since the last Board meeting, the office received 1 new request under the Freedom of Information Act, for records related to the new ward maps. This agency had no responsive records and so advised the requestor.

H. <u>New Ordinance</u>

Staff is in the process of creating an engrossed version of the Ordinance that will take effect on July 1, 2013. It will be posted on our website.

Pat Doerr, Registered Lobbyist, introduced himself at 3:30 p.m. and was excused by the Chair.

VII. MATTERS CONSIDERED BY THE BOARD IN EXECUTIVE SESSION

I. <u>APPROVAL OF EXECUTIVE SESSION MINUTES</u>

The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve the minutes of the March 20, 2013 meeting in executive session.

II. <u>CASES</u>

A. Advisory Opinions

1. Case Nos. 12067.1.A and 12067.2.A, Part III Limitations on Solicitations of Donations

After reviewing Part III of this combined case, the Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent), under **amended** §2-156-142 of the Governmental Ethics Ordinance, when it takes effect that, aldermen may solicit donations to non-profit organizations from companies doing business with the City, subject to the limitations set forth in new subsection (h) of §2-156-142.

2. Case No. 12072.A, Representation, Fiduciary Duty

The Board discussed staff's report about the status of a reconsideration request from a City employee with respect to an issued Board opinion. The employee resigned and withdrew the request for reconsideration, thus there was no Board vote on the matter.

3. Case No. 13018.A, City Agency

The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve staff's recommendation that two boards were not City agencies and to adopt staff's advisory opinion and letter to the requestor memorializing the Board's determinations.

B. Dismissed/Referred Complaint Report

4. Case No. 13016.C, No Jurisdiction

The Board discussed staff's report about an anonymous complaint alleging misuse of City resources over which the Board had no jurisdiction because the complaint was anonymous, and which the staff referred to the Office of Inspector General. The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve staff's recommendations.

5. Case No. 13019.C, Misuse of Position

The Board discussed staff's report about an anonymous complaint alleging misuse of City position over which the Board had no jurisdiction because the complaint was anonymous, and which the staff referred to the Office of Inspector General. The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve staff's recommendations.

6. Case No. 13020.C, Possible Fraud

The Board discussed staff's report about an anonymous complaint alleging possible residency violations, and possible fraud committed by a City employee, over which the Board had no jurisdiction because the complaint was anonymous, and which the staff referred to the Office of Inspector General. The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to approve staff's recommendations.

Staff reported that the employees named in the cases were determined to be in violation of the Ethics Ordinance for failing to timely file their 2012 Statements of Financial Interests ("FIS"). Staff reported that it was just recently informed that these employees were on leave for much of 2012 until now. The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to vacate these determinations, and close these two cases.

<u>Appointed Official – Case to be Closed</u> 9. Case No. 12045.15.FIS, Close

Staff reported that, at the Board's August 12, 2012 meeting, the appointed official named in this case was determined to be in violation of the Ethics Ordinance for failing to timely file the 2012 Statements of Financial Interests ("FIS"). Staff reported that the official filed his FIS and that staff received a report from the Mayor's office regarding its actions. The Board VOTED 5-0 (Hon. Michael J. Gallagher and Daisy S. Lezama, absent) to close the case.
