
Amounts in Thousands

- ➤ The 2023 Budget Recommendation appropriates \$310.7 million to DSS, which is an increase of \$2.65 million, or 0.9%, from the revised FY22 budget.
- ➤ The appropriation category driving the FY23 increase is Contractual Services, which is increasing by \$4.96 million, or 4.7%, from the revised FY22 budget.
- ➤ The Department receives 99.9% of its funding from Local funds.
- ➤ The proposed FY23 Budget appropriates **2,258 positions** to the DSS, which is 24 positions more than FY22.
- ➤ COFA estimates DSS's vacancy rate to be 18.8%, as of Oct 2022.


