

## **News & Updates**

The Illinois Department of Public Health recently issued Influenza Testing and Reporting Guidance<sup>1</sup> which outlines influenza testing recommendations and reporting requirements.

Vaccination is the best way to protect against influenza infection and all Chicagoans six months and older are encouraged to get vaccinated. Chicagoans should ask their healthcare provider or pharmacist about vaccine availability. Uninsured or underinsured adults and children 0-18 years old who are uninsured, underinsured, or Medicaid (Title XIX) insured can visit a CDPH Walk-in Immunization Clinic<sup>2</sup> to receive the flu vaccine; currently, two CDPH walk-in clinics have resumed immunization services. ## What is the risk?

Currently, the risk of influenza infection is low.




Figure 1. Number of influenza-associated ICU hospitalizations reported for Chicago residents, for the current season (2020-2021) and previous season (2019-2020), October-May.

Are severe cases of influenza occurring? For the week of May 2-8, 2021, no influenzaassociated ICU hospitalizations were reported (Figure 1).

Since September 27, 2020, one influenzaassociated ICU hospitalization has been reported.

## Which influenza strains are circulating?





Figure 2. Percent of specimens testing **positive** (by RT-PCR) for influenza by subtype as reported by local laboratories serving Chicago hospitals, for the <u>current season (2020-2021) October-May</u>.

Data on influenza virus test results are reported by Chicago laboratories performing influenza RT-PCR. For the week of May 2-8, 2021, 0 of the 452 reported specimens tested for influenza were positive (**Figure 2**).

Since September 27, 2020, 5 of the 24,714 reported specimens that were tested for influenza have been positive. The cumulative percent of specimens testing positive for influenza is lower than previous seasons for the same time period. The number of reported specimens tested for influenza is 42% lower compared to the same time period last season (**Figure 3**).<sup>§</sup>

# How much influenza-like illness is occurring? Figure 3. Percent of medically-attended outpatient visits

Several outpatient clinics throughout Chicago participate in CDC's Influenza-like Illness Surveillance Network (ILINet) by reporting on a weekly basis the total number of outpatient clinic visits, and of those visits, the number with influenza-like illness (ILI). For the week of May 2-8, 2021, 38 of the 5,996 (<1%) reported outpatient clinic visits were due to influenza-like illness (**Figure 3**).




Figure 4. Percent of **emergency department** visits attributed to influenza-like illness for Chicago zip codes based on chief complaint data submitted to **ESSENCE**, Chicago, by week, for the current season (2020-2021) and previous two seasons, October-May.

In addition to ILINet, ESSENCE is an electronic syndromic surveillance system that utilizes the chief complaints of patients visiting emergency departments to monitor for influenza-like illness. Currently, ESSENCE captures nearly every emergency department visit in the city on a daily basis. For the week of May 2-8, 2021, 156 of the 20,738 (<1%) total emergency department visits were due to influenza-like illness (**Figure 4**).

**Figure 5** represents the percentage of emergency department visits due to influenza-like illness aggregated by patient zip code. For the week of May 2-8, 2021, 0 of 59 zip codes had ILI activity levels that were moderate to high.

### Where can I get more information?





Figure 5. Influenza-like Illness (ILI) activity level by patient zip code determined by chief complaint data submitted to **ESSENCE**, Chicago, for week of May 2-8, 2021 (Week 18)
