Host your next event at the historic Chicago Cultural Center. The stunning landmark offers a variety of options for large and small gatherings.

It is home to two magnificent stained-glass domes, one of which is the world's largest Tiffany dome. The grace of this historic building is enhanced by breathtaking views of Millennium Park, located just across the street. The Chicago Cultural Center is managed by the Chicago Department of Cultural Affairs & Special Events (DCASE).

The Events office is operated on behalf of DCASE by Transwestern Commercial Services Illinois, LLC and is charged with upholding all City of Chicago laws and DCASE policies and procedures.

ROOM FEE & CAPACITY SCHEDULE

Operational Fees Include (but not limited to):

- Building security
- Custodial services
- Labor
- Audio-Visual Capabilities
- Standard DCASE- owned equipment
- Off- Duty Officers

Operational fees are added to private event room rental rates to cover staffing and other requested event details. The estimated cost of the rentals are based on event details and number of hours required.

The hall features graceful arches inlaid with sparkling mosaics, along with 25 Tiffany glass chandeliers spaced throughout the room. With a stunning view of Millennium Park, Preston Bradley Hall is ideal for all types of private events.

GAR HALL & ROTUNDA

Newly renovated to its original grandeur, this space was dedicated to the Grand Army of the Republic to honor veterans of the Civil War. Offering impressive views, soaring walls rise to a coffered ceiling.

The Rotunda serves as the large foyer to the Hall and showcases the building's second glass-domed ceiling, designed by the Healey Millet Glass Company. These rooms can be utilized separately or as one combined space.

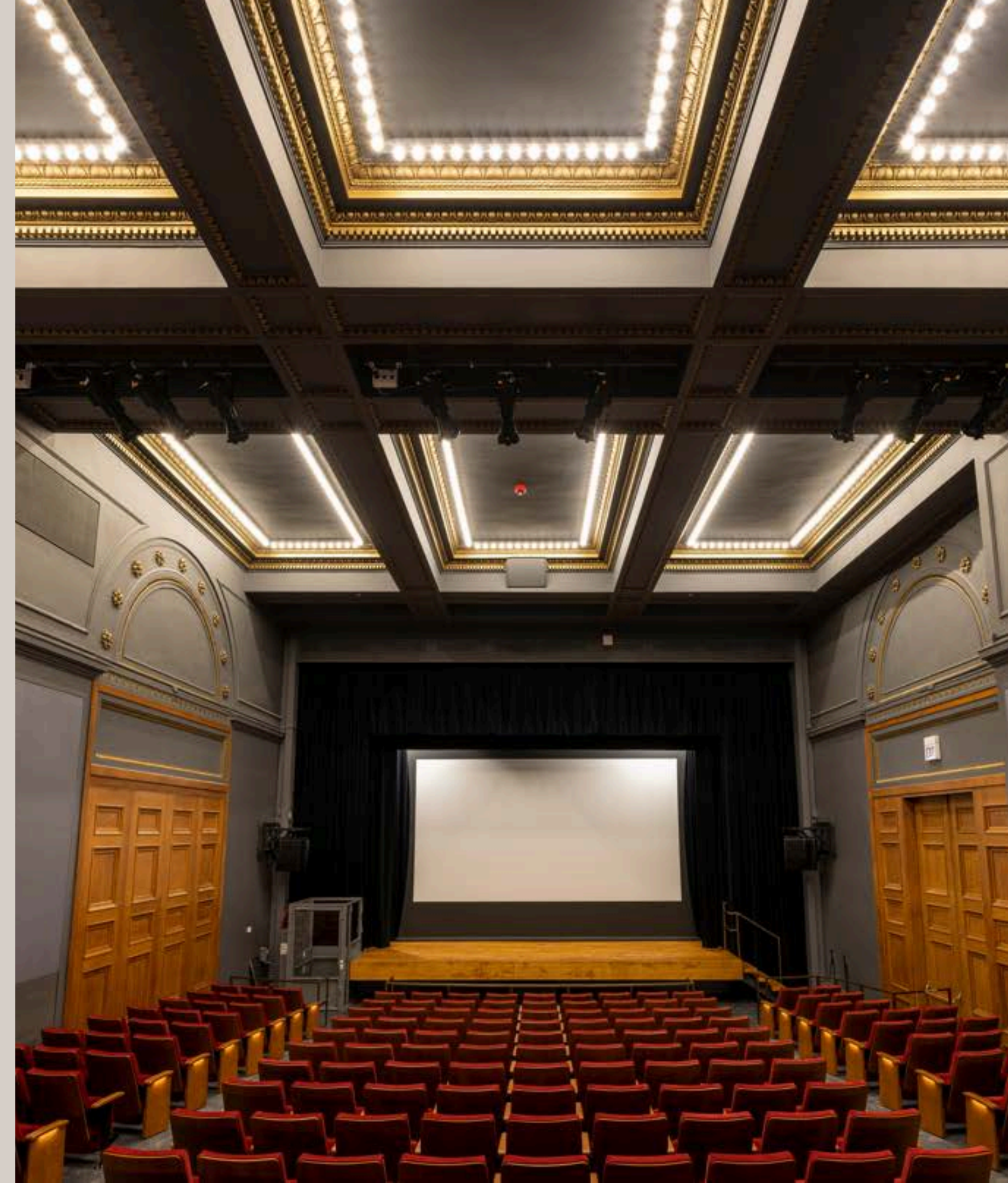


CLAUDIA CASSIDY THEATER

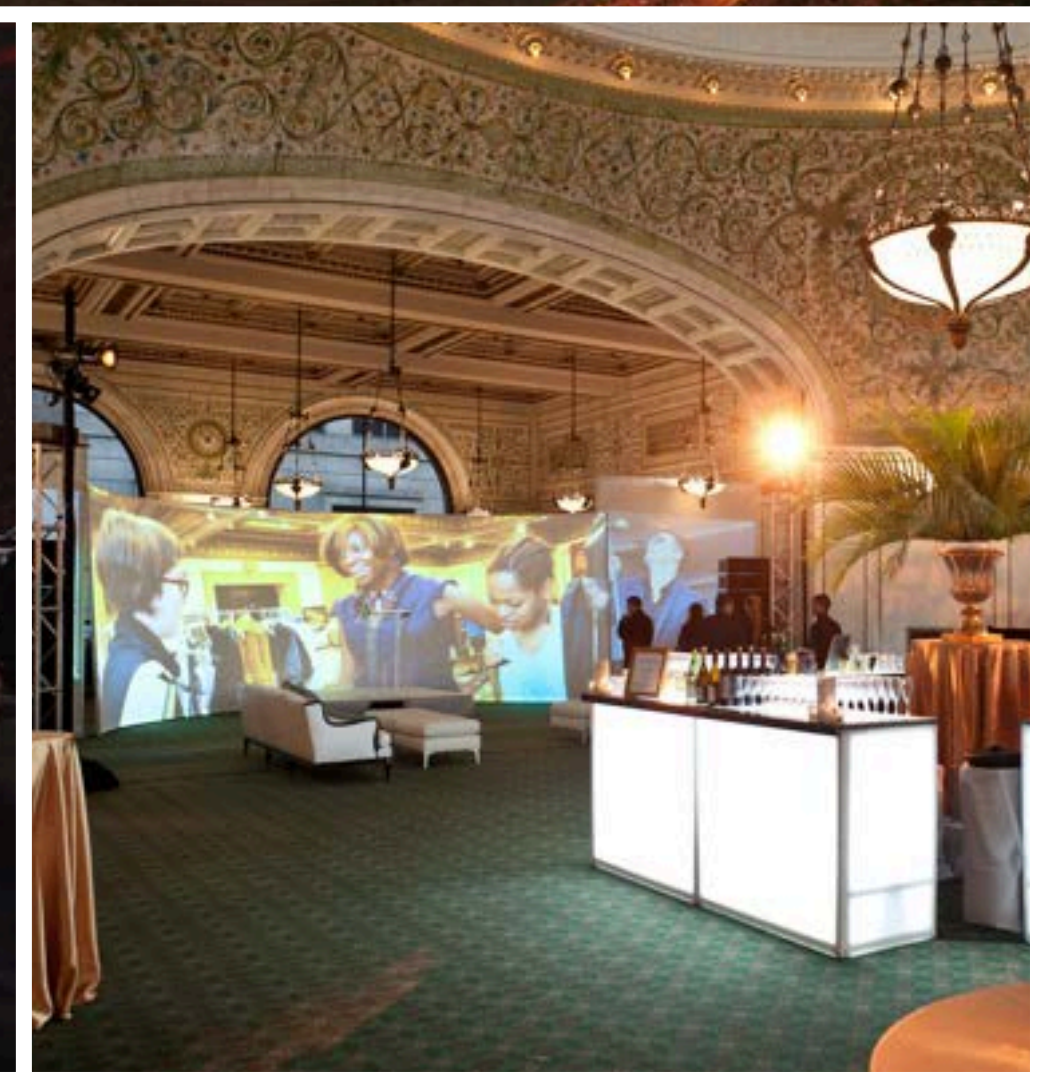
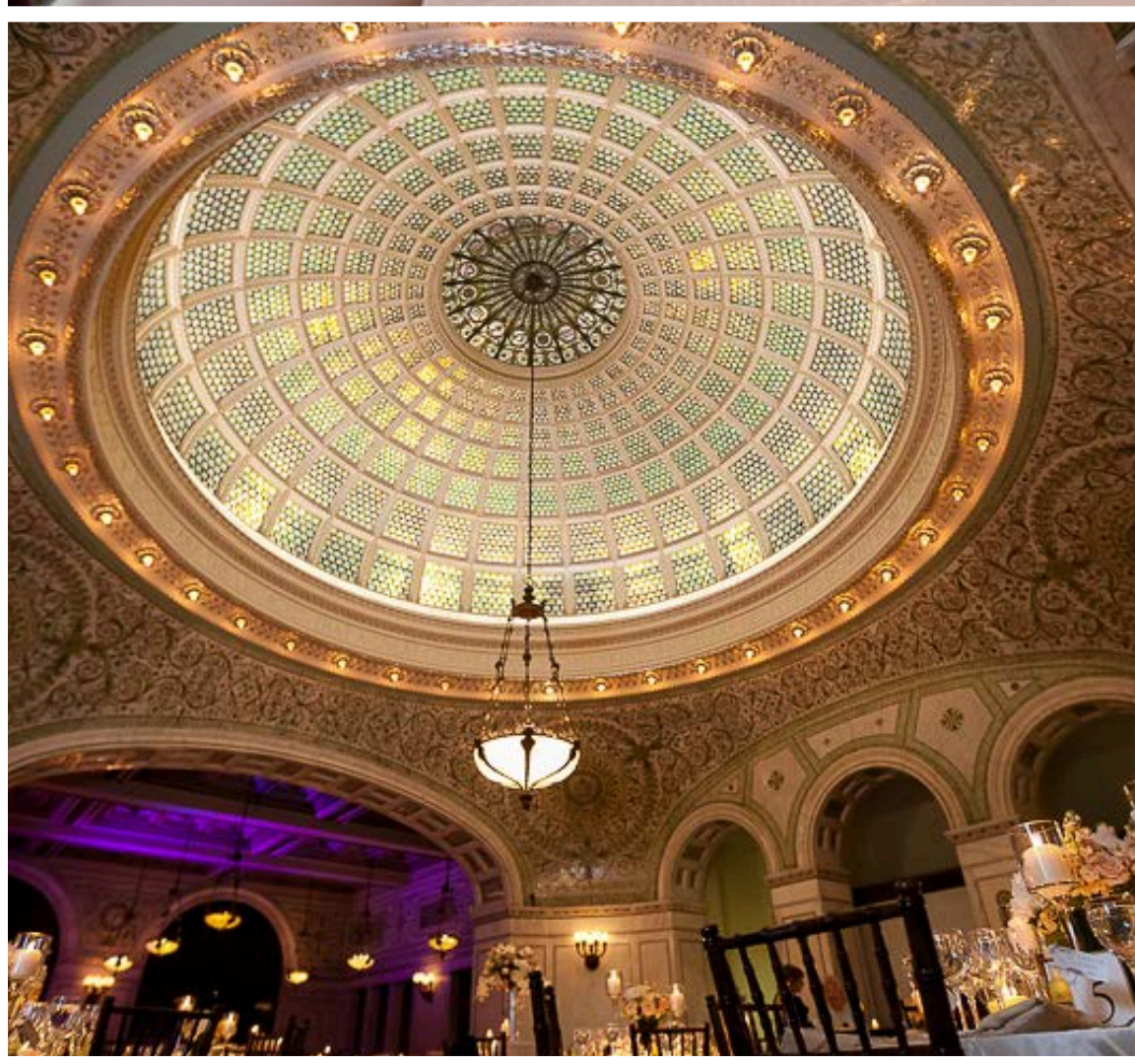
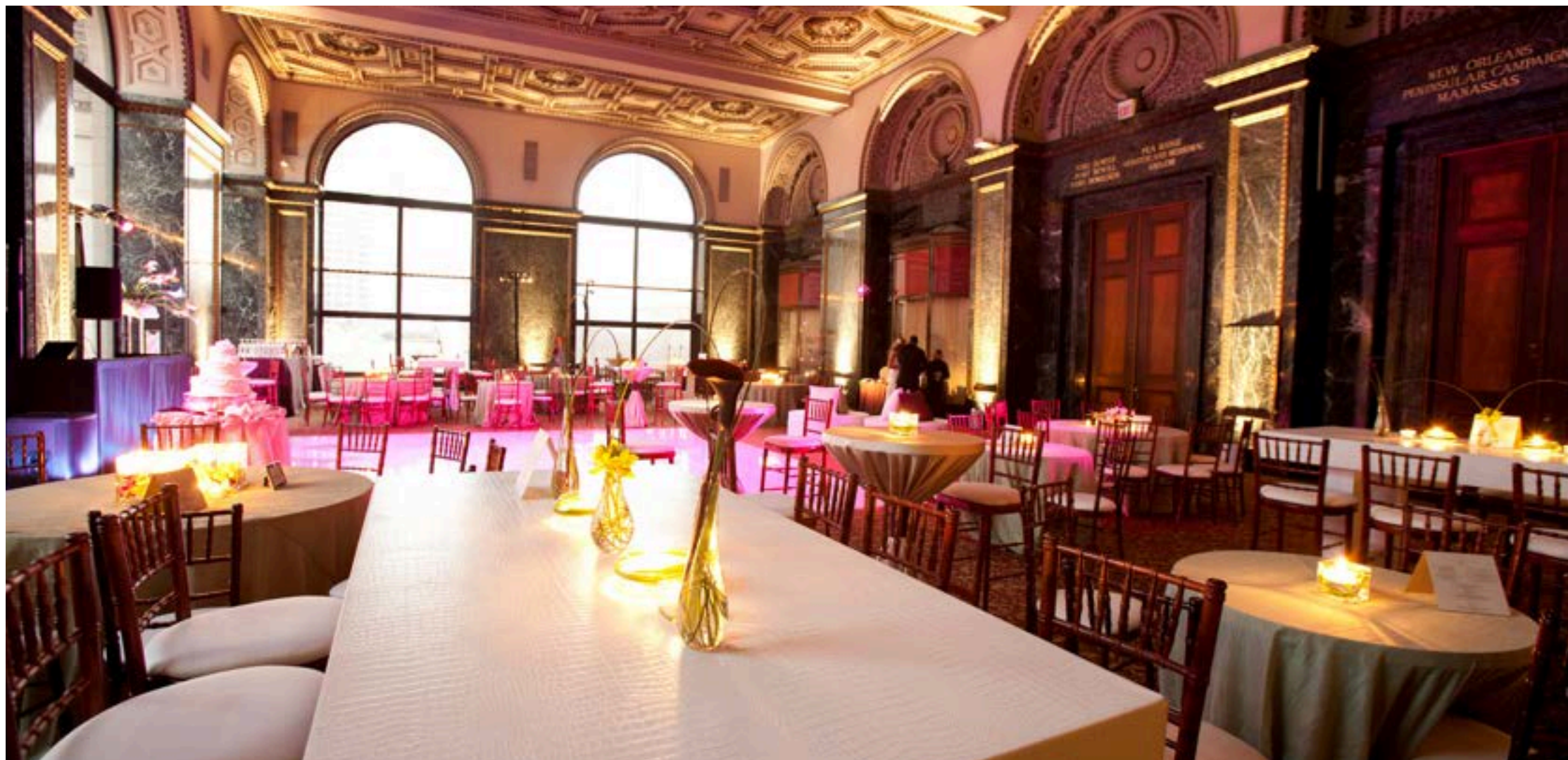
RECOMMENDED CATERING
