CLASS TITLE: SENIOR HEARING OFFICER

CHARACTERISTICS OF THE CLASS

Under direction, serves as second in charge to the Senior Administrative Law Officer overseeing contested administrative hearings (in person or contested by mail adjudication) for alleged violations of City's ordinances in the Vehicle Hearings Division; and performs related duties as required

ESSENTIAL DUTIES

- Assists in supervising staff of Administrative Law Judges responsible for conducting administrative hearings, and reviewing contested cases of alleged violations of the city's parking, red light and speed camera ordinances
- Assists in the oversight and monitoring of administrative review decisions of division's cases appealed to the Circuit Court of Cook County, ensures decisions are entered into case management system. Maintains database of all Circuit Court dispositions
- Ensures that pre-seizure, immobilization and impoundment of vehicle adjudications are handled in a timely manner
- Assists and assigns caseloads, prepares work schedules and monitors staff productivity to ensure the timely and efficient processing of hearings
- Assists in formulating and implementing policies and procedures pertaining to the administrative adjudication process
- Reviews and compiles monthly statistical summary reports
- Coordinates and participates in the development of training programs for Administrative Law Judges
- Reviews hearing records to ensure that rendered decisions are in accordance with established ordinances, regulations and legal standards
- Supervises department staff engaged in various administrative and clerical support activities
- Presides over administrative hearings involving complex legal issues
- Reviews and analyzes proposed legislative amendments
- Conducts in-depth research to prepare comprehensive case summaries for cases which include but are not limited to driver's license suspensions
- Schedules all petitions to vacate filed by Department of Finance and ensures that cases are adjudicated by the Chief Administrative Law Judge
- Researches and responds to legal inquiries from the general public, City departments, and governmental agencies
- Serves as a liaison to City departments and governmental agencies including Corporation Counsel, the Cook County Circuit Court, and Illinois Secretary of State

NOTE: The list of essential duties is not intended to be inclusive; there may be other duties that are essential to particular positions within the class.

MINIMUM QUALIFICATIONS

Education, Training, and Experience

• Graduation from an American Bar Association (ABA) accredited law school, and admitted to the practice of law in the State of Illinois for at least three (3) years (*Per provision of the City ordinance Article 1, Section 2-14-040*)

Licensure, Certification, or Other Qualifications

Admission to the Illinois Bar is required

Knowledge

Considerable knowledge of:

Skills

- *ACTIVE LEARNING Understand the implications of new information for both current and future problem-solving and decision-making
- *ACTIVE LISTENING Give full attention to what other people are saying, take time to understand the points being made, ask questions as appropriate, and not interrupt at inappropriate times
- COMPLEX PROBLEM SOLVING Identify complex problems and review related information to develop and evaluate options and implement solutions
- *CRITICAL THINKING Use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions, or approaches to problems

- *MONITORING Monitor and assess performance of one's self, other individuals, or organizations to make improvements or take corrective action
- NEGOTIATION Bring others together and trying to reconcile differences
- OPERATIONS ANALYSIS Analyze needs and product requirements to create a design
- PERSUASION Persuade others to change their minds or behavior
- *COORDINATION WITH OTHERS Adjust actions in relation to others' actions
- *INSTRUCTING Teach others how to do something
- *LEARNING STRATEGIES Select and use training/instructional methods and procedures appropriate for the situation when learning or teaching new things
- SOCIAL PERCEPTIVENESS Demonstrate awareness of others' reactions and understand why they react as they do
- JUDGEMENT AND DECISION MAKING Consider the relative costs and benefits of potential actions to choose the most appropriate one

Abilities

- *COMPREHEND ORAL INFORMATION Listen to and understand information and ideas presented through spoken words and sentences
- *SPEAK Communicate information and ideas in speaking so others will understand
- *COMPREHEND WRITTEN INFORMATION Read and understand information and ideas presented in writing
- *WRITE Communicate information and ideas in writing so others will understand
- *COME UP WITH IDEAS Come up with a number of ideas about a topic
- *MAKE SENSE OF INFORMATION Quickly make sense of, combine, and organize information into meaningful patterns

Other Work Requirements

- PERSISTENCE Persist in the face of obstacles on the job
- INITIATIVE Demonstrate willingness to take on job challenges
- LEADERSHIP Demonstrate willingness to lead, take charge, and offer opinions and direction
- ADAPTABILITY/FLEXIBILITY Be open to change (positive or negative) and to considerable variety in the workplace
- *ATTENTION TO DETAIL Pay careful attention to detail and thoroughness in completing work tasks
- *ANALYTICAL THINKING Analyze information and using logic to address work or job issues and problems
- SOCIAL ORIENTATION Prefer to work with others rather than alone and being personally connected with others on the job
