





RE: Emergency Contract Request – Heritage Environmental Services, LLC

DATE: November 15, 2007

As stated in previous e-mails, and a matter of public safety, DOE dispatched Heritage Environmental on various emergencies throughout the City to remove and dispose of hazardous waste materials. Below is a recap of the emergencies responded to by Heritage. Also attached is the requisition and invoices for each emergency response for immediate payment.

1. At the request of the Chicago Fire Department, DOE dispatched Heritage to 3134 N. Kolmar due to a chemical spill. A 250 gallon tote of hazardous waste was abandoned and leaking in the alley. The cost for this emergency was \$4,954.64.
2. At the request of the Fire Department, DOE dispatched Heritage to 2338 N. Melvina to remove drums of gasoline from an illegal vehicle chop shop. The cost for this emergency was \$1,700.01.
3. DOE authorized Heritage to remove fly dumped drums on city property located at 4600 W. Flournoy. The cost for this emergency was \$2,169.97.
4. DOE dispatched Heritage to remove a drum of flammable material dumped in the alley at 7000 s. Honore. The cost for this emergency was \$384.73.
5. DOE dispatched Heritage to remove an abandoned drum in the alley located at 1124 N. Mayfield. The cost for this emergency was \$586.42.
6. There was a truck accident at I-55 and Kedzie Ave. which resulted in a fuel spill. The cost for this emergency was \$11,367.20.
7. Heritage was dispatched to 6401 S. Drexel due to an oil spill. The cost

for this emergency was \$2,643.51.
