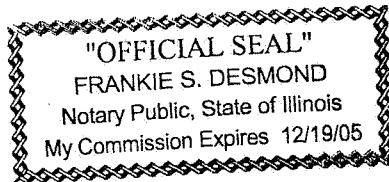



Estimated duration of this Project is **Sixty(60) calendar days**.


