#### How do we expect this to be impacted by amnesty in 2012 and 2013?

In 2012, 95,923 people participated in the ticket payment plan. Of these, 62,119 were 'hardship'. 57,876 ticket plan participants failed to keep up with their payments. Of these, 17,168 were 'hardship' participants. \$107,440,070\* came in through the payment plan program in 2012. There was no amnesty in 2012 and there is not one planned for 2013. \*This figure reflects a cash basis.
