

## Current Expediter Licensees as of 12/24/2012

### License Information

An Expediter License is required for any person who, for compensation, seeks to obtain licenses, permits and certificates for another person. "Expeditors" work on the behalf of developers, contractors, businesses and homeowners in obtaining permits, licenses and certificates. An Expediter also monitors the progress of applications through any stage of the application review process or inquires as to the status of an application within any City department. An expeditor may also pick up a license or permit application or certificate from any City department. The Licensing of Expeditors was required as of January 9, 2009

#### Class A:

This license is required for legal entities (Corporations, LLC's, Limited Partnerships) who operate a business of expediting.

#### Class B:

This license is required for Sole Proprietors engaged in the business of expediting, or for individuals who perform expediting as employees of a Class A or Class B licensee.
