## Schedule a Public Vehicles Service Appointment

To provide efficient customer service and minimize customer wait times, all public vehicle and public chauffeur licensees and license applicants must schedule an appointment during:

Monday, December 18, 2023 to Tuesday, January 9, 2024

Individuals must secure a scheduled online appointment for BACP Public Vehicle Facility (2350 W. Ogden) services during this time frame. BACP will resume walk-in service on January 10, 2023.

- 2. Click on the button that reads "Schedule a Public Vehicles Service Appointment".

- 4. You can reschedule or cancel your booking by clicking the link in your confirmation email
- 5. Appear for the scheduled appointment and show the appointment confirmation on your electronic device when entering the facility
