ORDER

On April 10, 2023, the Superintendent of Police filed with the Police Board of the City of Chicago charges against Police Officer Sammy Encarnacion, Star No. 11790 (hereinafter referred to as "Respondent"), recommending that Respondent be discharged from the Chicago Police Department for violating the Department's Rules of Conduct (a copy of the charges is attached as Exhibit A).

On May 1, 2023, the Superintendent moved to withdraw the charges against Respondent without prejudice because Respondent resigned from the Chicago Police Department. The Police Board has considered the Superintendent's motion.

IT IS HEREBY ORDERED that the Superintendent's motion is **granted**, and the proceedings before the Police Board are terminated.

Exhibit A Charges

Attached are the charges filed with the Police Board by the Superintendent of Police. The public is reminded that the filing of charges is not evidence of guilt. The accused officer is presumed innocent and is entitled to a fair hearing at which the Superintendent has the burden of proving guilt by a preponderance of the evidence. In this case, the accused officer resigned from the Chicago Police Department prior to a full hearing on the charges.

CHARGES AGAINST POLICE OFFICER SAMMY ENCARNACION

Police Officer Sammy Encarnacion, Star No. 11790, is charged with violating the following Rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 1: Violation of any law or ordinance.

Rule 2: Any action or conduct which impedes the Department's efforts to

achieve its policy and goals or brings discredit upon the Department.

Rule 3: Any failure to promote the Department's efforts to implement its policy

or accomplish its goals.

Rule 6: Disobedience of an order or directive, whether written or oral

Rule 8: Disrespect to or maltreatment of any person, while on or off duty.

Rule 9: Engaging in any unjustified verbal or physical altercation with any

person, while on or off duty.

Rule 15: Intoxication on or off duty

Rule 38: Unlawful or unnecessary use or display of a weapon.

Rule 39: Failure to immediately make an oral report to the desk sergeant at the

District of occurrence and to follow such oral report with a written report on the prescribed form, whenever a firearm is discharged by a member.



 - b. Rule 2, any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department;
 - c. Rule 3, any failure to promote the Department's efforts to implement its policy or accomplish its goals;
 - d. Rule 15, intoxication on or off duty; and/or

While committing one or more of the above acts, Officer Encarnacion said words to the effect of "Fuck you. You're a bitch." Officer Encarnacion thereby violated:
 - a. Rule 1, violation of any law or ordinance (720 ILCS 5.0/12-3(a) (Battery) and/or 720 ILCS 5.0/12-3.2-A-1(Domestic Battery);
 - b. Rule 2, any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department;
 - c. Rule 3, any failure to promote the Department's efforts to implement its policy or accomplish its goals;

- d. Rule 8, disrespect to or maltreatment of any person, while on or off duty; and/or
- e. Rule 9, engaging in any unjustified verbal or physical altercation with any person, while on or off duty.
- 13. On or about July 7, 2016, at or near Encarnacion knowingly and without justification and/or consent caused bodily harm to and/or made physical contact of an insulting or provoking nature with her, in that he pushed her to the ground and/or dragged her body. Officer Encarnacion thereby violated:
 - a. Rule 1, violation of any law or ordinance (720 ILCS 5.0/12-3(a) (Battery) and/or 720 ILCS 5.0/12-3.2-A-1(Domestic Battery);
 - b. Rule 2, any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department;
 - c. Rule 3, any failure to promote the Department's efforts to implement its policy or accomplish its goals;
 - d. Rule 8, disrespect to or maltreatment of any person, while on or off duty; and/or
 - e. Rule 9, engaging in any unjustified verbal or physical altercation with any person, while on or off duty.
- 14. On or about October 31, 2017, Officer Encarnacion failed to secure his weapon and/or allowed to possess it. Officer Encarnacion thereby violated:
 - a. Rule 2, any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department; and/or
 - b. Rule 3, any failure to promote the Department's efforts to implement its policy or accomplish its goals.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Sammy Encarnacion, Star Number 11790, be discharged from the Chicago Police Department.
