Enclosed please find an executed Initial Certificate of Completion regarding the Mercy Hospital and Medical Center redevelopment project.

After further review of documents pursuant to Section 7.01 of the First Amendment Redevelopment Agreement between the City of Chicago and Mercy Hospital and Medical Center, dated June 7, 2011, the Department of Housing and Economic Development (HED) finds that the developer has satisfactorily performed its covenants and agreements as it pertains to Section 7.01(a) the Initial Certificate of Completion, which states the following:

- (i) The Exterior Facade Restoration Work has been completed and approved in the sole discretion of HED; and
- (ii) The City's Monitoring and Compliance Unit has verified that the Developer is in full compliance with City requirements regarding Prevailing Wage set forth in <u>Section 8.09</u> with respect to the construction of the Exterior Facade Restoration Work; and
- (iii) There exists neither an Event of Default (after any applicable cure period) which is continuing nor a condition or event which, with the giving notice or passage of time or both, would constitute an Event of Default.

This executed Initial Certificate of Completion releases Mercy Hospital and Medical Center only from those covenants and agreements addressed in Section 7.01(a) of the First Amendment Redevelopment Agreement. All other covenants, agreements, and representations associated with the Redevelopment Agreement are still in force. INITIAL CERTIFICATE OF COMPLETION

PURSUANT TO Section 7.01(a) of the Mercy Hospital and Medical Center First Amendment Redevelopment Agreement (the "Agreement") dated June 7, 2011 by and between the City of Chicago, an Illinois municipal corporation (the "City"), Mercy Hospital and Medical Center, an Illinois not-for-profit corporation, the term "Developer", as used in this Agreement, shall mean the Mercy Hospital and Medical Center. The City, by and through its Department of Housing an Economic Development hereby certifies as follows:

- 1. <u>Completion in accordance with Section 7.01(a)</u>. Developer has fulfilled its obligation to complete the Exterior Façade Restoration Work (as defined in the Agreement) located on the property legally described on Exhibit A hereto, in accordance with the terms of the Agreement.
- 2. Other provisions of the Agreement; no waiver. Except with respect to the terms of the Agreement specifically related to the Developer's obligation to complete the Project in accordance with Section 7.01(a) of the First Amendment Redevelopment Agreement, which the City hereby certifies have been satisfied:
 - a. all executory terms and conditions of the Agreement and all representations and covenants contained therein remain in force and effect; and
 - b. the issuance of this Initial Certificate of Completion shall not be construed as a waiver by the City of any of its rights and remedies pursuant to such executory terms.

Except that part of Lot C lying East of a line, being the West line of Antonio's Subdivision according to the plat thereof recorded April 9, 2007 as document 0709906052, described as follows:

All in Cook County, Illinois.
