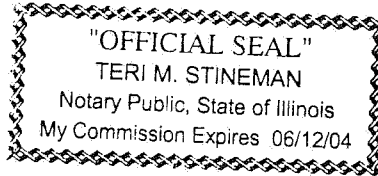

- Backfill and restore ground with sod.




