The scope of work to be performed under this sub-order is removal and refinishing of the sidewalk surface on State Street.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The State Street Commission has requested that CDOT remove and refinish the sidewalk surface along State Street in late Spring 2007 due to upcoming City events. Due to the relatively small scope and in order to meet the construction schedule for late Spring 2007, CDOT must use the JOC procurement system. The term agreement for RCMA was not used because this work is specialty work requiring the use of the Blastrac System to strip the existing sidewalk surface and then to reseat the sidewalk with Pebblesheen.
