### III. Tree Planting Update

- Ambassadors find locations and put door hangers on doors for citizens to opt out. This method has proven to have positive improvements over the previous opt in door hangers.
- One stumbling block was people calling the 311 app requesting tree plantings, door hangers were not hung to give people a way to opt out. This caused some trees that were planted to have to be dug up and transplanted. This situation has been rectified by removing all anonymous requests for tree plantings.
- 2022 proved easier to plant than 2023 because their was a backlog of request for tree plantings.

### IV. Landscape Ordinance Plan

- Review the landscape ordinance plan and look at how it affects trees.
- · Collaborate with other working groups to be sure that siloing does not happen.
- · Put a working group together to eventually work on this.
- Move from prescriptive to performative goals.

#### V. 1990 Mayor Live Tree Removal Directive

- This gives discretion of Alderman discretion over living tree removals.
- The concern is this policy has been in place since the 1990's and has become outdated with a more robust forestry department with many Certified Arborists on staff.
- A motion was made to send the mayor a message to update the removal process for living parkway trees.
- Verbiage will be worked on.

#### VI. Education

- Chicago Public Schools has agreed to coordinate getting material into schools about trees.
- The idea is to look at coordinating it with planting schedule.
