CORONAVIRUS IMPACTED

PUBLIC PASSENGER VEHICLE OPERATIONS UP TO APRIL 10, 2020

The Department of Business Affairs and Consumer Protection (BACP), in support of Governor Pritzker's "Stay at Home" order and the City of Chicago's efforts to minimize the transmission of the Coronavirus (COVID-19), has implemented the following protocols.

BACP offices, including Ogden and 39th Street, remain closed to the public in accordance with social distancing efforts. BACP will send out a future notice with information on when BACP offices will reopen to the public.

BACP staff will continue to work servicing public passenger vehicle licensees during closure to the public. BACP staff will be available by e-mail.

I. PUBLIC PASSENGER VEHICLE LICENSE RENEWALS

Renewal of the following public passenger vehicle licenses will be deferred until April 30, 2020:

- Public Chauffeur (taxicab, livery, pedicab, and horse drawn carriage drivers) Licenses with expiration dates between February 1, 2020 and **April 10, 2020**.
- Pedicab Vehicle Licenses expiring March 31, 2020. Licensees are encouraged to submit license renewal documents directly to BACPPV@cityofchicago.org.
- Transportation Network Provider Licenses expiring March 31, 2020. Licensees are encouraged to submit license renewal documents directly to BACPPV@cityofchicago.org.

- Taxicab Medallion Licenses that expired February 29, 2020. Licensees are encouraged to submit license renewal documents directly to BACPPV@cityofchicago.org.
 - ▶ If applicable, BACP encourages licensees to submit licensing documents to BACPPV@cityofchicago.org to begin the renewal process remotely.

II. PUBLIC PASSENGER VEHICLE INSPECTIONS

Public vehicle inspections scheduled at the BACP Public Vehicle Inspection Facility (2420 W. Pershing Road/39th Street) from March 19, 2020 to **April 10, 2020** will be rescheduled.

An updated Public Vehicle Inspection Schedule will be posted at the BACP webpage at Chicago.Gov/BACP. BACP shall notify taxicab affiliations and license managers by e-mail of updated public vehicle inspection dates.

Public passenger vehicle licensees may request inspection date scheduling changes by sending an e-mail to BACPPV@cityofchicago.org.

III. SURRENDERING TAXICAB MEDALLION LICENSES

Taxicab medallion licensees surrendering licenses may send completed License Surrender Forms by e-mail to BACPPV@cityofchicago.org. A fillable License Surrender form is available to download at the BACP webpage.

A taxicab medallion licensee may initiate a "un-surrender" to place a taxicab back into service by sending an e-mail to BACPPV@cityofchicago.org. A request to "un-surrender" must be supported by proof of current mandated insurance. If approved, a "Letter to Operate" will be e-mailed to the taxicab medallion licensee if the hard card and medallion have been surrendered to our office.
