Summary of public comments:

Jose Abonce from Reimagine Public Safety wanted to discuss an opportunity to host a meeting or perhaps having a special meeting that can revolve having conversations about alternative responses to policing.

How can we look at the CARE model and expand that to the southwest side. Jose discussed the possibility to. How can we change 9-1-1 calls and what can we offer something else. How can we begin to create an alternative dispatch model. How can we review what the Neighborhood Policing Initiative.

Rosemarie Dominguez: mentioned the meetings that CPD 10th district had on community engagement. Engagement is still a concern with hearing from the community on better measures for police and resident engagement.

Rosie had the opportunity to meet with the co- founder of El Viento running in group in little village. They have vocalized how their initiative in reclaiming the streets through running. Have mentioned they would often get stopped by CPD and questioned why they would run, indicating a non communal approach with the running group. The group have vocalized that they run on 26th street because of the lack of lighting on 25th, 27th Street, etc.

Elianne Bahena mentioned how the city's infrastructure budget or programs that may be able to address this, followed by meeting with the alderman.

Discussions:

Nominating committee: looking for feedback currently. Starting February, weekends will be dedicated to Interviews.

March 8, nominations are due. Mayor Johnson, will have to decide from those who have been nominated. Present 14 nominations, and from there Mayor Johnson to select 7, or

There was a question that was raised on how many people could apply? What are the requirements?

Response: there is no limit. Nominating chairs created a rubric that pertains to relevant experiences and conduct block interviews with rotating rooms.
