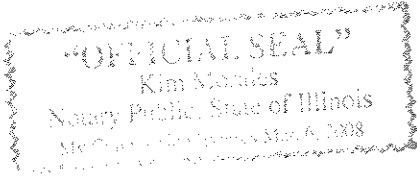

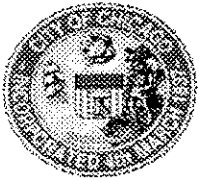

The scope of work to be performed under this sub-order is removal of existing granite paver median and curb, installation of planting soil, irrigation, concrete curb and landscaping.
