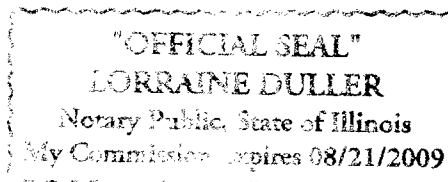

This Department is requesting that the Contractor apply a cementitious overlay on the existing concrete floor of the coal handling tunnel at Western Avenue Pumping Station. The overlay shall be placed such that water infiltrating the tunnel walls and roof shall be directed to an existing drainage opening in the floor. In addition, an existing door and stairwell floor at the south end of the tunnel shall be modified to direct water to the floor drainage opening and an existing sump pump pit shall be filled in.

Estimated duration of this Project is (3) three Weeks.
