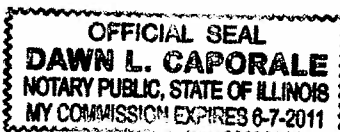





1. **Please describe the major features of this project.**

This is a JOC project and the construction was already completed. However, "Green Initiative" signs need to be added to this JOC project and, therefore, a change order is requested per this memo. The value of the original JOC contract was \$809,253.97. The additional cost for the two signs will be less than \$15,000.

2. **Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.**

This is a JOC project and the construction was already completed. However, "Green Initiative" signs need to be added to this JOC project and, therefore, a change order is requested per this memo. It makes sense to stay with the JOC contractor to complete this scope of work.

3. **If the project is a one trade project, please provide additional explanation of why it would be in the city's best interest to do the project under JOC:**

The original project was not a one trade project. This change order will involve one installer but two different suppliers. As it is a change order to a JOC project, it makes sense to stay with the JOC contractor to complete this scope of work.

4. **If it is anticipated that over 25% of the project will consist of Non-prepriced items, please provide an explanation on why JOC should be used.**

This project will be priced fully by the JOC contractor.

5. **If some elements of the proposed JOC project scope of work are covered by city term agreements, explain why they are included in this JOC project instead of being procured through the term agreements.**

No elements are covered under city term agreement.
