





Removing existing damaged planter fencing and replacing it with new planter fencing .The planter fencing is located at.

This work is a time sensitive installation on a small scale.The Alderman has requested replacement at this location before the end of the 2009 Spring construction season. Pacific Construction has been chosen to install this fencing as additional work to JOC # 08-84-10-009 Streetscape Maintenance 2008/Phase II. That project is still under the construction phase and by adding this additional requested work, money will be saved by the city due to the fact that the contractor is already mobilized in the project area.

This project involves the use of multiple trades for purchase and construction.
