

Committee on Finance

A communication recommending a proposed ordinance concerning the authority to issue Second Lien Wastewater Transmission Revenue Bonds, Project and Refunding Series 2018. Amount of Bonds not to exceed: \$400,000,000. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.

A communication recommending a proposed ordinance authorizing the issuance of Second Lien Water Revenue Project and Refunding Bonds, Series 2018-1 and Subordinate Lien Obligations, Series 2018-1.
