Please be advised that, pursuant to City Council Rule 14 and Section 2-156-080(b) of the Municipal Code of Chicago, I invoked Rule 14 and have recused myself from participation and voting on the following records on the agenda of the City Council on December 18, 2019:

Committee on Housing & Real Estate – Record #: O2019-8603 – Negotiated sale of vacant owned City property to Commonwealth Edison. I am abstaining from voting on this item. Within the preceding twelve months, I was a member of a consulting firm that worked with Commonwealth Edison, and although I have divested from the firm, I was not involved in the negotiated sale of this property, and did not receive any income or compensation for the sale of this property, out of an abundance of caution, I will abstain.

Committee on Transportation & Public Way – Record #: O2019-8710 – For Commonwealth Edison to maintain and use, as now constructed, one (1) kiosk on the public right-of-way adjacent to its premises known as 358 East 47th Street. Within the preceding twelve months, I was a member of a consulting firm that worked with Commonwealth Edison, and although I have divested from the firm, I was not involved in this matter, and did not receive any income or compensation for this matter, out of an abundance of caution, I will abstain.
