Alderman Hairston asked what type of police powers the University of Chicago Police have.

The UCPD was not formally created until the 1960s. In 1989, the Illinois Local Governmental Law Enforcement Officers Training Board certified the University of Chicago Campus Police Department as a law enforcement agency under the administration of the Illinois Police Training Act.

The University of Chicago Police Department serves pursuant to 110 ILCS 1020/1 "Private College Campus Police Act" and pursuant to Chapter 4-340 "Special Policemen and Security Guards" of the Municipal Code of Chicago.

Members of the campus police department shall have the powers of municipal peace officers and county sheriffs, including the power to make arrests under the circumstances prescribed in Section 107-2 of the Code of Criminal Procedure of 1963, as amended, for violations of state statutes or municipal or county ordinances, including the ability to regulate and control traffic on the public way contiguous to the college or university property, for the protection of students, employees, visitors and their property, and the property branches, and interests of the college or university, in the county where the college or university is located. Campus police shall have no authority to serve civil process.

The extension of the jurisdiction was granted by the City Council in 1993, 2001, 2004, and 2011. Currently, the jurisdiction of the campus police of the University of Chicago, are to all that area bounded as follows:

Beginning at the intersection of the north curb line of East Oakwood Boulevard and the west curb line of South Lake Shore Drive; thence west to the east curb line of Lake Park Avenue; thence north to the north curb line of East 37th Street; thence west to the west curb line of South Cottage Grove Avenue; thence south to the north curb line of East Pershing Road; thence west to the west curb line of South Langley Avenue; thence south to the south curb line of East Oakwood Boulevard; thence east to the west curb line of South Cottage Grove Avenue; thence south to the north curb line of East 44th Street; thence west to the west curb line of South St. Lawrence Avenue; thence south to the south curb line of East 45th Street; thence east to the west curb line of South Cottage Grove Avenue; thence south to the west curb line of South Payne Drive; thence south to the south curb line of East 55th Street; thence east to the west curb line of South Cottage Grove Avenue; thence south to the south curb line of East 61st Street; thence west to the west curb line of South Evans Avenue; thence south to the south curb line of East 64th Street; thence east to the west curb line of South Ellis Avenue; thence south to the south curb line of East 65th Street; thence east to the east curb line of South University Avenue; thence north to the south curb line of East 64th Street; thence east to the west curb line of South Stony Island Avenue; thence north to the south curb line of East 61st Street; thence east to the west curb line of South Lake Shore Drive; thence, north to the place of beginning.

The information provided below is in response to questions posed at our department's hearing on October 30, 2014, to discuss the proposed 2015 budget.

Alderman Pope asked how we work with federal agencies on intrastate and interstate criminal cases.

The CPD's Bureau of Organized Crime works with various federal agencies on investigations into organized criminal gangs, drug trafficking organizations and gun trafficking that spans state lines. For instance:

- **BATF/CPD Joint Gun Trafficking Task Force** - Gang Investigations Division's CAGE Unit (Chicago Anti-Gun Enforcement) has several officers assigned to the BATF/CPD Joint Gun Trafficking Task Force. These CPD officers are designated TFOs (Task Force Officers) with federal jurisdictional powers that allow them to conduct investigations across the country, along with their BATF counterparts. This Task Force's primary responsibility is to conduct investigations into the source of crime guns recovered in Chicago when the recovered firearm emanated from a source state other than Illinois.
- **FBI Joint Task Force on Gangs** – This FBI led task force focuses on gang related crimes, exceptionally violent gang members and conducts long term investigations into gang leaders as well as their hierarchy and structure. CPD members are assigned as federally deputized task force officers giving them national jurisdiction when conducting an investigation under the auspices of the JTFG.
- **HIDTA (High Intensity Drug Trafficking Area) / DEA Task Force – and DEA Strike Force** – Both of these Task Forces have CPD members assigned as federally deputized task force officers. Both of these task forces focus on DTOs (drug trafficking

organizations). These DTOs can be cartel level or gang level. While their investigations focus primarily on the Chicagoland area, they have the ability and jurisdiction to take the investigation across state lines.

- **US Marshall's Fugitive Task Force** - This task force is made up of Deputy US Marshalls and CPD members, who are federally deputized, and focuses on locating and apprehending wanted fugitives regardless of State boundaries.
- **Lake County HIDTA** – The CPD's Bureau of Organized Crime is moving forward with a recent proposal to assign a CPD member to the Lake County Indiana HIDTA task force. This will give the Department a better liaison to NW Indiana law enforcement and help to facilitate joint investigations into criminal organizations that operate on both sides of the Illinois / Indiana border.
- **Gang Conferences** – The CPD / Bureau of Organized Crime has been asked by the US Attorney's office to give organized crime/gang presentations at law enforcement conferences in Indiana on several occasions. In 2008, members from the Bureau of Organized Crime gave presentations in Lafayette, Indiana and recently on September 4, 2014, at the request of the Indiana US Attorney's Office, gave presentations at a large gang conference (400 attendees) held in Indianapolis, Indiana. These events not only serve as an excellent information sharing opportunity; it also serves to develop cross border contacts.
- **CPD's CLEAR system** – the CPD's CLEAR data system is one of the best crime related searchable law enforcement (LE) data systems in the country. Not only do numerous LE agencies across Illinois have authorized access to this data base, many LE Agencies in NW Indiana also have access. This helps to bridge the information sharing across State lines and agencies.
