#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Section 4-60-023 of the Municipal Code of Chicago hereby amended by inserting the language underscored, and by deleting the language struck through, as follow:

#### 4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

(42.304) On the west side of Michigan Avenue from Madison Street to Monroe Street; and on the north side of Madison Monroe Street from Michigan Avenue to Garland Court.

(Omitted text is unaffected by this ordinance)

On the west side of State Street from Benton Couch Place to Randolph Street; and on the north side of Randolph Street from State Street to Dearborn Street.

(42.347) On the east side of Dearborn Street from Randolph Street to Benton Couch Place; and on the south side of Benton Couch Place from Dearborn Street to State Street.

(42.348) On the west side of State Street from Lake Street to Benton Couch Place; and on the north side of Benton Couch Place from State Street to Dearborn Street.

(42.349) On the east side of Dearborn Street from Benton Couch Place to Lake Street; and on the south side of Lake Street from Dearborn Street to State Street.

(Omitted text is unaffected by this ordinance)

(42.351) On the east side of Dearborn Street from Lake Street to Wacker Street Drive; and on the south side of Wacker Drive from Dearborn Street to State Street.

(42.352) On the west side of Dearborn Street from Wacker Street <u>Drive</u> to Lake Street; and on the north side of Lake Street from Dearborn Street to Clark Street.

(42.353) On the east side of Clark Street from Lake Street to Wacker Street Drive; and on the south side of Wacker Street Drive from Clark Street to Dearborn Street.

SECTION 2. This ordinance shall be in full force and effect upon passage and publication.
