The Chicago Department of Aviation (CDA) and Alaska Airlines have announced that as of Thursday, March 14, 2019, Alaska Airlines has relocated its operations from Terminal 3 to Terminal 2 at O'Hare International Airport, including ticketing, check-in, gate assignments and baggage claim.

Alaska Airlines passengers are advised to check in at Terminal 2, and to claim luggage at Baggage Carousel 1 on the lower level. Alaska Airlines' flights will now operate from gates G4 and G6 located on the G Concourse.
