#### Eligible WAV Taxicab Drivers MUST at a minimum:

- ✓ Hold a valid current City of Chicago Public Chauffeur license in good standing.
- ✓ Be in compliance with all City laws.
- ✓ Have been operating a Chicago licensed taxicab for at least 3 consecutive years.
- ✓ Operated a Chicago licensed WAV taxicab during most of the 2020 calendar year.
