

NOTICE TO APPLICANTS FOR EMPLOYMENT COMPLIANCE WITH CHILD SUPPORT OBLIGATIONS

Municipal Ordinance 2-152-155 requires that every person who is given an offer of employment with the City of Chicago shall file an AFFIDAVIT OF CHILD SUPPORT OBLIGATIONS disclosing any unpaid child support obligations they owe. This Affidavit shall be filed prior to being hired and will be verified for accuracy by the City.

If you owe any unpaid court-ordered child support, you will not be retained by the City of Chicago unless you take one of the following actions for discharging this debt within six (6) months of the start of your employment:

- You have paid this debt and provided a certified court order or certified clerk's record that no support is due and owing.
- You have entered into a court-approved agreement for the payment of all child support owed and you are in compliance with this agreement.

Failure to settle child support debts will be grounds for discharge.
