- 1) Question: I'm writing to formally inquire about the expense we should expect for the street opening permits per location regarding the Private Drain Projects.  
**Answer:** The cost of the street opening permit is waived for DWM.
  
- 2) Question: We wish to bid on the Private Drain Repair Program projects. Our financial falls within the range to qualify as a mid-sized business, but we don't have the SBA Specialty Area or NAICS code to enter into the "Affidavit of Mid-Sized Business Status" document. Would we have the option to apply for these two items if we are the low bidder, or must they be in place at the time of the bid?
