Camera Violation Review Debt Relief Program

Frequently Asked Questions

For a limited time, the City is waiving penalties and collection fees for red light camera and speed camera violations that were subject to the Review and Refund Ordinance of 2016. In order to participate, vehicle owners must pay the eligible violations in full by the deadline.

How is the Debt Relief Amount Due calculated?

For eligible violations, penalties and collection fees will be waived, and any partial payments you have already made will be applied.

Example:

Red Light Violation Fine Late Payment Penalty Collection Fee	\$100 \$100 <u>\$</u> 44
Less penalty and collection fee Debt Relief Amount Due	\$244 <u>-\$144</u> \$ 100
Debt Relief Amount Due	2 100

How long does the Debt Relief Program last?

The Debt Relief Program is available for 30 days from the date on the Confirmation of Liability or administrative order.

Can I receive a payment plan and Debt Relief discount?

No. To receive the Debt Relief discount, eligible violations must be paid in full by the stated deadline.

Do I have to pay all of my violations to participate?

No. You can pay any number of eligible red light or speed camera violations, but each violation <u>must be paid in full</u> to receive the Debt Relief discount on such violation.

What happens if I don't pay my violations in full?

Any Debt Relief eligible violation that is not paid in full will revert back to the full amount due after the stated deadline, and the City will resume collection efforts.

What if I have filed for bankruptcy?

NO PAYMENT IS DUE at this time if you currently have a bankruptcy case pending or if <u>all</u> of the following apply:

- (1) You previously filed for bankruptcy;
- (2) You notified the City of the bankruptcy;
- (3) Your bankruptcy case is not currently pending;
- (4) The violations listed on the front side of this notice were issued before you filed for bankruptcy; and You received a bankruptcy discharge in Chapter 13 under

§ 1328(a) of the Bankruptcy Code.

In order to ensure your payment is applied correctly, please write the 10-digit violation number(s) on the check or moneyorder.

All payments must be <u>received</u> no later than the applicable deadline in order to be eligible for Debt Relief.
