



# **Deferred Compensation Plan**

The City of Chicago offers a Section 457 deferred compensation plan to all employees. As an employee of the City of Chicago, you are eligible to enroll and contribute to the 457(b) plan. This plan provides you an opportunity to invest a portion of your salary on both a pre-tax and/or Roth (after-tax) basis to save for retirement. Employees who enroll in the plan make voluntary contributions each pay period and invest in an array of investment options to help prepare for their income needs in retirement. This account is a voluntary contribution that can help to bridge the gap between your defined benefit plan (pension) and how much you will need while in retirement. There are some Trade groups within the City of Chicago who offer a 401(a) match that has been negotiated though their union.

Special 457 Catch-up: \$46,000
